We couldn't imagine that synagogues would not be houses of worship, but monuments of attacks. Combating antisemitism has been and continues to be a top AJC priority. From advocating for advancing hate crimes legislation, to bridge-building with other communities, and educating diplomats and elected officials, AJC NY has been on the front lines working 24/7 to combat antisemitism.

Toward that end, in 2019 AJC NY established a prominent group of interfaith and intergroup partners called the Community of Conscience. These partners have been outspoken against the uptick in antisemitic incidents and work together to combat all forms of hate. Community of Conscience

At Global Forum 2019 in Washington DC, Dr. Bernice King, Dr. Martin Luther King's daughter, and faith and community leaders from around the country representing millions of Americans stood together to establish AJC's Community of Conscience.

AJC NY launched our local Community of Conscience in November 2019 with the support of leaders from many of New York's diverse religious and ethnic communities. Since then, the group wrote a letter of support to the Satmar community after the attack at the Jersey City supermarket, walked over the Brooklyn Bridge together in solidarity with the Jewish community after a rash of antisemitic hate crimes, held a forum where each community spoke about discrimination and bias directed towards their group, and advocated for hate crimes legislation. As COVID-19 has brought an increase in anti-Asian rhetoric, our Community of Conscience has spoken out. The Community continues to grow as does our signature bridge-building advocacy.

Antisemitism at Our Front Door

One of AJC's core priorities is combating antisemitism at home and abroad. On the one-year anniversary of the Pittsburgh attack, October 25-26, we joined with our partners of all faiths to #ShowUpForShabbat in synagogues in all five boroughs. On October 27, we held *A Day of Action to Combat Antisemitism*. Lt. Governor Kathy Hochul, Attorney General Letitia James, and Mayor Bill de Blasio spoke to hundreds of advocates at Central Synagogue, while hundreds more watched on live stream. Governor Cuomo issued a proclamation declaring October 27 *A Day of Action to Combat Antisemitism* in NYS and lit state buildings and bridges blue and white in solidarity with the Jewish community.

In April, AJC NY advocated for the passage of the *No Hate in Our State* legislation, which successfully resulted in the passage of the *Josef Neumann Domestic Terrorism Act*, renamed after the victim of the December 2019 antisemitic attack in Monsey, NY. This act, a first-inthe-nation piece of legislation, defines hate-fueled murder as an act of domestic terrorism. In addition to virtual meetings with officials, we advocated with all 63 NY State Senators and 150 State Assembly Members (91 of whom are in NYC) asking them to support this important legislation.

Promoting Israel and Countering Extremism

Promoting Israel's place in the world is a top AJC priority. AJC NY does so at the United Nations, on college campuses, with Consuls General and elected officials. This year, AJC NY led the first of its kind Project Interchange alumni mission to Israel. Alumni, including elected officials, a university president, Muslim, Christian and Latino leaders joined together for a deeper dive into the complexities and wonder of Israel. As a result, these PI leaders are already speaking out in support of Israel.

AJC NY also advocated for policies that protect America, Israel, and our allies. For decades we have spoken of the threat of Hezbollah's worldwide terror network. We continue to advocate that the European Union classify Hezbollah in its entirety a terror organization with 11 European countries and the EU Mission to the UN. We thanked the Argentine mission to the UN and Argentine Consulate, whom we work closely with, on the 25th anniversary of the deadly Buenos Aires JCC (AMIA) bombing for classifying Hezbollah as a terror organization. We will not rest until the entire European Union does the same.

ACCESS

For over 15 years, ACCESS NY, AJC's young professionals division for those aged 22-40, has been at the forefront of leading a new generation of AJC advocacy. Through pioneering diplomatic, legislative, and interfaith/intergroup work, ACCESS NY has cultivated new relationships and initiatives for AJC. Through ACCESS NY, ACCESS leaders gain invaluable leadership experience and advocacy experience that will further enable them to become the next leaders of AJC NY.

This year, ACCESS NY launched its inaugural ACCESS Leadership Fellowship (ALEF), an eight-part series designed to give an elite group of young professionals an exclusive deep-dive into the work of AJC and ACCESS. ALEF graduates have become highly engaged in ACCESS NY, with many traveling with AJC on advocacy missions.

With rising antisemitism in NY and across the world, ACCESS NY has been a driver in pushing back against antisemitism. ACCESS NY worked with its partners at the New York Urban League Young Professionals to speak about the rising antisemitism in Crown Heights and to promote mutual respect between the Black and Jewish communities. ACCESS NY also launched its "Prep Your Rep" campaign to educate and advocate with local elected officials about rising antisemitism. ACCESS NY has been advocating with its diplomatic partners about combating antisemitism and in adopting the International Holocaust Remembrance Alliance Working Definition of Antisemitism.
